#### Why was this done?

There was a requirement to upgrade SYSPRO Reporting Services to use Crystal Reports 2013.

#### What was done?

SYSPRO Reporting Services was upgraded to use Crystal Reports 2013 for client-side reporting. Server-side reporting was upgraded to use Crystal Reports Server Embedded 2013. There is a new **Version of Crystal** setup option that enables you to choose between **Crystal 2008** and **Crystal 2013**.

## Where can I see the change?

The **Version of Crystal** setup option is located on the **Reporting** tab of the **Admin System Setup** program.

## Why was this done?

There was a requirement to improve the management of post-dated checks, specifically those collected during an AR Collection run.

## What was done?

A new **PD check status required** setup option has been added to the **AR Setup** program. When you enable this option, only post-dated checks that have been cleared are posting during a payment run. The **Post Accounts Receivable Setup Options** and **Query Accounts Receivable Setup Options** business objects have been changed to include the status of post-dated checks.

## Where can I see the change?

The new **PD check status required** setup option is available on the **Payment Run** tab of the **AR Setup** program.

## Why was this done?

This forms part of the enhancement that was released in Port 005 relating to the ageing of AR invoices based on user-defined ageing buckets instead of the Accounts Receivable period end dates.

## What was done?

Two custom form filter selection fields have been added to the **AR Setup** program. These fields enable you to filter customers for inclusion in Accounts Receivable reports based on the ageing buckets used. The values displayed in the dropdown are the caption names of the custom form fields added against customers using the **AR Customer Maintenance** program. These selections were added specifically

for use with the **Number of days fixed invoice terms** option which enables you to define your own ageing buckets.

## Where can I see the change?

The new Customized filter selection fields: **Custom form filter 1** and **Custom form filter 2** are available on the **User Defined** tab of the **AR Setup** program.

## Why was this done?

This forms part of the ongoing improvements and additions to the SYSPRO Espresso suite of applications.

## What was done?

Additional applications and functionality include:

- An **Available to Promise** application to view the Available to Promise (ATP) details for a specific stock code/warehouse combination.
- A **Supply Chain Transfer** application to transfer stock between multiple warehouses in your company.
- A **BOM Structure Query** application to view a graphical representation of the structural relationship between parent and component parts in the bill of material for a stock code.
- **Override price** and **Override price code** fields have been added to the **Sales Order** application, allowing you to change the price and price code on an order.

A change to the Espresso framework for use with barcode scanners has also been made. However, this will only be available when the SYSPRO barcode program is released at a later date.
