The following is a summary of the enhancements that have been implemented for this port.

SQL Session ID column displayed for logged-in users

Why was this done?

There was a requirement to view the SQL Session ID against each logged-in user so that administrators could determine which processes may need further attention.

What was done?

The **Job Logging Query** and **Logged in Users Query** programs have been updated to display a **SQL Session ID** in a new list view column.

The column is not shown by default and will need to be added to the list view using the **Field Chooser** function in the respective program.

Where can I see the change?

If you add the **SQL Session ID** list view column to the **Job Logging Query** and **Logged in Users Query** programs then you can view the **SQL Session ID** against each logged-in user.

Why was this done?

A new business object was created to enable e.net Solutions developers to develop applications that require Load Planning functionality.

Why was this done?

There was a requirement to optimize the **Requisition Create Purchase Orders** program for SQL companies as well as to simplify the process of creating purchase orders from requisitions.

What was done?

The following changes were made to the **Requisition Create Purchase Orders** program:

- The user interface has been changed to more closely resemble a typical review-style program.
- Selection criteria can be changed without having to exit the program.
- The **Criteria** form and the **Suggested Purchase Order** list views are visible by default.
- The **Supplier Information** and **Requisition Detail** panes are hidden by default.
- The docking structure has been improved and consolidated to make it easier to customize.
- The purchase order number is now requested on a form, allowing for customization.
- The loading of suggested purchase orders has been improved with SQL optimization.



- Some columns have been relocated to the **Field Chooser** to enable better visibility of column headings. You may want to review the **Field Chooser** function to identify columns to add to the list view.

In addition, the following new columns are available:

- Due date
- Quote version
- A **Current holder** selection field has been added that enables you to select a current holder (providing you have not enabled the **Only select requisition from current holder** preference in the **Requisition Entry** program).

Where can I see the change?

The changes are visible when you load the **Requisition Create Purchase Orders** program.

Why was this done?

This forms part of the **Descriptive tax code** facility that was implemented in SYSPRO 7 Update 1 to cater for a longer tax code field required by Malaysian tax legislation.

A new **Use descriptive tax codes** option was added to the **Tax Setup** program which (when selected) enabled a longer descriptive tax code to be linked to the standard tax code. A tax cross-reference file enables the longer descriptive tax code to be displayed instead of the standard tax code.

What was done?

If the **Use descriptive tax codes** setup option is enabled within the **Tax Setup** program, then:

- The **AR Payments and Adjustments** program displays the descriptive tax code when adjusting the balance of an outstanding invoice on a customer's account.
- The <AdjustmentTaxCode> element of the **AR Payments and Adjustments** business object caters for a 20-digit tax code when posting adjustments.
- The **RMA Line Receipt** program accepts the new descriptive tax code.

Where can I see the change?

The **AR Payments and Adjustments** program displays the **Descriptive tax code** if this feature has been enabled within the **Tax Setup** program.

Operator Copy business object caters for user-defined roles

Why was this done?

There was a requirement to create new operators with specific roles, instead of using the source operator roles when creating operators using the **Copy Operator** business object.

What was done?

The following elements have been added to the Input XML for the **Operator Copy** business object:

- <Role1>
- <Role2>
- <Role3>
- <Role4>
- <Role5>

The element values are the role codes for the new operator, as indicated in the following Input XML sample fragment:

- <Role1>004</Role1>
- <Role2>099</Role2>
- <Role3>673</Role3>
- <Role4>053</Role4>

- `<Role5>008</Role5>`

If you don't want to specify a role for one of the role codes, you can pass a value of zero (e.g. `<Role5>000</Role5>`).
