## **Port 009**

The following is a summary of the enhancements that have been implemented for this port.

## New Operator Program List report

#### Why was this done?

There was a requirement to produce a report detailing program access per operator.

#### What was done?

There is a new **Operator Program List** report that enables you to report on program access per operator. The report can be filtered by operator, role and group and you can optionally select to ignore role or group access in the event that you only want to report on a single configuration. You can optionally select/ignore the display of contact information and multiple access details and also whether to display conflicting programs.

#### Where can I see the change?

The **Operator Program List** report can be run from the **Administration** folder of the **Available Reports** pane in SYSPRO Reporting Services as well as the **Administration** > **Security** > **Reports** folder of the SYSPRO **Program List** pane.

## Separate program to browse SO contract prices

## Why was this done?

There was a requirement to improve the performance and user experience of the **SO Contract Prices** program by implementing a browse on contract prices into its own program.

#### What was done?

There is a new **Browse on Sales Order Contract Prices** program. The program defaults to loading customer contract prices (20 contracts at a time) but includes the option to load buying group contracts. You can also maintain notes against each customer/buying group contract price listed.

#### Where can I see the change?

The Browse on Sales Order Contract Prices program can be loaded from the Sales Orders > Contract Pricing > Browses folder of the SYSPRO Program List pane.

## Separate program to capture AR terms due dates

#### Why was this done?

There was a requirement for a separate program to capture invoice and discount due dates for AR terms.

#### What was done?

The due date functionality of the **AR Invoice Terms Maintenance** program has been moved to a new program which will be used to capture invoice and discount due dates.

#### Where can I see the change?

The **AR Terms Due Dates** program is loaded from the **Accounts Receivable** > **Setup** folder of the SYSPRO **Program List** pane.

## Copy custom form data when copying purchase orders

#### Why was this done?

There was a requirement to include custom form data when copying purchase orders.

#### What was done?

When copying purchase orders within the **PO Entry** program, there is a new **Copy custom forms** option that (if selected) will include the copying of custom form data.

## Where can I see the change?

The new **Copy custom forms** option is displayed on the **Copy Purchase Order** window when you select **Copy** from the **Function** pulldown menu of the **PO Entry** program.

## Fine-tuning MRP calculation (under construction)

#### Why was this done?

There is a requirement to be able to exclude specific sales orders, quotes, purchase orders, or requisitions from the **MRP Requirements Calculation**.

#### What was done?

Over the past few ports, a number of programs have been (and are in the process of being) updated to take account of this new functionality. This facility is, however, not yet available to implement.

#### Where can I see the change?

The changes are still in progress and will be available to implement at a later date.
