Adjustments on AP check remittance

Why was this done?

There was a requirement to save the adjustment amount when posting a supplier-customer contra, and to display this value on the **AP Check and Remittance Print** report.

Currently no adjustment values are reflected in the AP Check and Remittance Print report.

What was done?

- The <InvAdjustmentAmt> element has been added to Crystal Reports
- The adjustment amounts are saved as separate values in the AP Invoice Posting program.

There was a requirement for additional filtering options in the **AR to Cash Book Integration Posting** business object and **AR Bank Deposit Slip** program.

What was done?

The following filters have been added:

• Range and List value filters have been added for Bank, Operator and Currency.

- List value filter has been added for Journal when doing a reprint
- All and Range filters have been added for Year and Period when doing a reprint

Journal filter options

Why was this done?

There was a requirement to always use the filter options when printing journals, regardless of the print status.

Currently the filter options are only available when the **Reprint** option has been selected.

What was done?

- All journals that match the filter criteria specified on the **Report Options** tab will be printed.
- The **Reprint** flag on the report will indicate if a journal has already been printed.
- The **Reprint** function has been removed.
